## Miller Message for November 2014

### The spotlight is on us

Over a long period, the Legacy Foundation has provided grants for specific projects undertaken by not-for-profit organizations in Lake County. As an example, they provided funds for air conditioning the Gardner Center on Lake Street, which has made this location a vibrant center for diverse community activities.

At the beginning of 2014, the foundation announced a change of direction, from funding individual requests to developing and implementing a collective impact plan for whole communities. This involves creating a vision of what a neighborhood sees as its future, detailing clear goals to achieve that vision, and formulating a plan of action to achieve the goals. The Miller Beach Arts and Creative District (MBACD), led by Karren Lee, has represented the Miller community in applying to become one of these "Spotlight Neighborhoods".

Last week, the foundation announced that the "Gary-Miller" community will, in fact, be one of the first two "Spotlight Neighborhoods". With this designation comes a grant of \$50,000 to hire a project coordinator, to work with Miller organizations and individuals in developing the community vision. There is also an implied commitment to fund some initial community project, to demonstrate that the Spotlight concept is about action, and not just talk. Eventually, the Legacy Foundation will also help locate funds for achieving the Miller community's vision.

Thanks, and congratulations, to the dozens of persons who have worked for the past year to achieve this first milestone for the Gary-Miller community.

### Knight grant program

What are your ideas for making Gary-Miller a better place? The Knight Foundation has made \$5 million available to solicit and implement ideas to make Knight Cities, including Gary, more successful. The ideas can be submitted by real people, rather than professional grant writers. They must be described in 150 words or less, and they should focus on the three drivers of city success – talent, opportunity, and engagement. The key criterion is innovation. After the most promising ideas have been identified, phase two of the grant process will deal with the cost of the proposals and their implementation.

Think about ideas for making our city more attractive to young adults who will build its future. Then, go online to [www.knightcities.org](http://www.knightcities.org) to enter the contest. And do it soon – the deadline for submittals is November 14.

**CRIME MAPS AVAILABLE.** Indiana University Northwest has collaborated with a number of local police departments, including Gary's, to produce on-line maps of crimes reported during specific periods of time. Just log on to [nwi.com/regionalcrimereport](http://nwi.com/regionalcrimereport). Selecting the community you want to view will give you its map, with symbols for various types of criminal activity. You can control the scale of the map by clicking on the + or – in the upper left corner. Clicking on the symbol gives you additional information about the location and time of the criminal activity.

**CORRECTION.** Last month's Miller Message indicated that Mayor Freeman-Wilson was opposing the reverse tax abatement for the Kaplan Trucking company, which is expanding its operation at Rt. 20 and Rt. 51. This was incorrect. The Mayor supported the abatement which was subsequently passed by the city council. The expansion project is moving forward.
