SOUTH SHORE MEETINGS. A number of MCC and MBA members attended meetings on August 5 and 6, sponsored by the Regional Development Authority (RDA), which dealt with plans for expansion of the South Shore Railroad. Proposals which would benefit our community include installation of dual tracks all the way from Gary to Michigan City (to speed travel times and eliminate delays) and installation of high-level platforms, at the Miller station, among others, (to speed boarding and exiting). Those who attended the meetings learned about plans for the railroad and had an opportunity to speak directly with the executives of NICTD (the railroad), NIRPC (regional planning) and the RDA (regional development), among others.

WIRT-EMERSON CLEANUP. In August, the MCC donated \$300 to support the volunteer cleanup effort at Wirt-Emerson School, which centered on removing weeds and vines from the athletic field.

LANDSCAPE DESIGN TALK. The monthly meeting of the Miller Garden Club will take place at **10:00 am on Saturday, September 19** at the Aquatorium in Marquette Park. The featured speaker will be Miller resident Jim Bertrand, who is an upscale landscape designer. Everyone is welcome

Since 2011, the Miller Beach Arts and Creative District, with its center of activity at the Marshall J. Gardner Center for the Arts on Lake Street, has presented a continuing stream of events -- exhibits, concerts, performances, films, street festivals, the Farmers Market, community meetings and fundraisers -- which bring life to the Miller commercial district, with the goal of attracting a diverse audience from a wide geographic area. IN THE BACKGROUND, The Arts District has been conducting art classes for residents of Parkshore Commons on County Line Rd., and it has recently been awarded a grant from the Legacy Foundation which will make it possible to continue the classes and to extend them to residents of the Lakeshore Dunes Apartments on Lake St. as well. At Parkshore Commons, over 40 students a day attended 8 classes throughout June.

Discouraging bad businesses

The MCC and the Miller Business Association (MBA) have supported actions to eliminate two disreputable local businesses.

A recent homicide took place in the parking area of **Murphy’s House of Pain** on Rt. 12, which was also the scene of two other killings in the past several years. Murphy’s liquor license was up for renewal in June, 2015, but they had liquor law violations and no one from the bar appeared to explain what remedial action had been taken. The license renewal was therefore continued to the July, August and September meetings of the Liquor Board. At the September Liquor Board meeting, repre-sentatives of the MCC and the MBA opposed the license renewal, helping to assure that it would be rejected. The bar has not been opened for about the past month and it is currently for sale.

The **‘Too Much Temptation Gentleman’s Club’** at 6900 Melton Rd. was recently cited for allowing prostitution and for permitting customers to enter with alcoholic beverages. These are criminal offenses, which will be pursued in court. Gary Councilman-at-large Ron Brewer is initiating action to remove the Club’s city business license, which should force it to close, regardless of what happens with the morals and liquor offenses.

HELP FOR GARY POLICE. Gary has been plagued recently by a spurt in criminal activity, including homicides, at the same time that the police department is seriously understaffed. Sheriff Buncich, with financing from the

Lake County government, has been offering continued manpower support to our city. In addition, other area law enforcement agencies have also contributed to a one-time 'sweep' on August 6, which picked up a significant number of individuals with out-standing warrants.
