

## Art to pop up and stay up

The final Pop-up Art event of the year is scheduled for Saturday, December 8 from 6:00 to 10:00 pm at the Marshall J. Gardener Center for the Arts, 540 S. Lake Street. The title of the show is **“In an Indescribable Vessel and Moving Rapidly Toward an Indistinct Shore.”** (You’ll have to come to see what that means). The participating Chicago-based artists are Christine Tarkowski, Jon Langford, and Damon Locks, plus video by Rob Shaw and additional musicians, Sally Timms and Martin Billheimer.

**This time, the art works will not immediately disappear. They will continue to be on display on Sunday, December 9 from 1:00 pm to 5:00 pm and on December 14 and 15 from 2:00 pm to 7:00 pm.**

A special guest will be Roy Dominguez, author of “Valor, The Odyssey of Roy Dominguez” as told to James Lane.

## A tale of two dances

Beginning in 1980, the MCC sponsored a big community party at the Marquette Park Pavilion every Valentine’s Day, to which everyone in Miller was invited. For thirty-two years, the MCC Dance was a big event of the winter season. Then, in 2011, the Pavilion was closed for renovation as the key part of the Marquette Park upgrade. To substitute for the February dance, the MCC sponsored a successful costume ball in October, 2010, a final event in the “old” pavilion. The renovation project subsequently took longer than planned, but when the refurbished hall reopened this fall, the MCC was eager to celebrate the opening with a rerun of the Masquerade Ball.

Prices at the renovated pavilion were significantly higher than two years before, so plans for the 2012 event called for hors d’oeuvres in place of a sit-down dinner, along with an open bar, a live band, and a ticket price of \$55, based on the attendance of 300 party-goers. It was hoped that the masked-ball format would attract a younger crowd to fill the pavilion.

Unfortunately, ticket sales lagged, and, in the end, only 107 people attended. MCC president Eric Reaves tried to cancel the event at the last minute, but we would have had to refund all the money collected for tickets, while the management of the pavilion would not refund the money we were committed to pay for rental of the building, food and drink. Those who attended were happy with the affair, but they didn't come near to paying the expenses.

If we had sold 300 tickets, the budget would almost have been balanced. However, income from 107 tickets did not come near to covering the costs.

**The MCC has planned to hold the traditional Valentine's Day dance on February 16, 2013, but we are now still deciding whether it is feasible to sponsor the event with the Marquette Park Pavilion as the venue. To break even, we would need to offer less, sell many more tickets, and probably raise ticket prices. At the same time, it is hard to see how paying more for less will encourage more people to attend. Keep tuned for news of the latest developments!**

## **Mayor clarifies park operation**

Following the recent community meeting with Mayor Freeman-Wilson, the MCC Shoreline Committee addressed to the mayor a number of questions regarding the management of Marquette Park. The mayor's response covered a variety of topics:

1. Marquette Park and the Pavilion will be managed as a single unit under the direction of the park department, which will manage the maintenance and marketing of both. Park department employees have been assigned to handle routine maintenance of the Pavilion and grounds, including the Kids Park.
2. All revenue generated in the park will go into a non-reverting fund for park maintenance. This includes revenues from the boat launch, parking, concessions, Pavilion rental, and fees. There will be a fee of \$5,000 for Special Events, and smaller fees of \$80 to \$200 for large groups and shelter rentals. The revenues will be

handles like all city income, to be deposited by the Controller and appropriated by the Common Council.

3. Park Superintendent Lori Latham will be involved in researching and writing grant applications for the park, with assistance from the South Shore Grant Center. The RDA is also offering assistance in identifying sources of funding for operation of the Park. In addition, the Park Department is working to establish eligibility for grants from the federal Land and Water Conservation Funds. They are also looking for funds from the state to finance boating safety classes next spring, along with water safety classes, conservation education and recreation programs.

4. A wide variety of activities will be permitted in the park from dawn to dusk. However, RVs and tents for camping are not allowed on the beach. Campers are referred to the National Park and to private campgrounds.

5. The Shoreline Committee sees trash collection as a continuing problem, especially on weekends. The City recognizes that they do not have the manpower to pick up trash consistently on Saturday and Sunday at all the city parks.

6. Marquette Park has two beach combers, only one of which is functional, but it is often not used because it is more efficient to pick up trash and dump it into a payload loader to minimize trips to the dumpster.

7. Rip tide warning flags will only be displayed in designated swimming areas. Visitors are discouraged from swimming at any time in other areas of the beach and when lifeguards are not present.

In the background, the Shoreline Committee has written a letter of support for a DNR grant which requests funds for a park Program Director. The committee has also written letters of appreciation to park department and public safety managers for the work they have done this past summer.

We have not yet heard any comment from Mayor Freeman-Wilson concerning the complaints voiced about the location of the trash collecting station at the east end of Marquette Park.

Finally, the Shoreline Committee is taking a few months off, unless some critical issue comes up. **Their next meeting is scheduled for February 21, 2013 (the third Thursday of the month).**
