Following the election of board members, the entire board will elect the officers who will lead the corporation during the coming year, including the President, three Vice-Presidents, the Secretary and the Treasurer. In case of election contests, the board members will vote by secret ballot to choose the winner.

## Miller hosts major concert by Chorus Angelorum musicians

For twenty-five years, the annual Chorus Angelorum concerts have been one of the musical highlights in Northwest Indiana. **This year, for the first time, the concert will take place at St. Mary of the Lake Church in Miller. On Friday, October 14 at 8:00 pm, 200 musicians will assemble under the direction of Mark Kruzcek, to present a program of classical music, featuring chorus, orchestra, and organ.**

The evening's program will include short works by Robert Schumann and Felix Mendelssohn, and the major work of the evening will be the **German Requiem of Johannes Brahms**, one of the great works of choral music. Performers will include a full orchestra, a choir of 120 voices, and soloists, all assembled in the sanctuary of St. Mary of the Lake Church, which is newly resplendent in white and gold.

## **Local COP program revived**

Continual reorganization of the Gary Police Department (GPD) has brought constant flux to the Community-Oriented Policing (COP) program. The Miller COP officers were reassigned in August, and, for a month or more, were not replaced. The MCC complained about the general lack of police protection and the absence of officers to follow up on COP office complaints. Now, the COP officers are back. **Ray Robinson and Marla Guye** have been assigned to the Miller-Aetna sector and are following up on COP complaints, along with responding to routine police calls.

Residents with public safety and code enforcement problems are encouraged to phone reports to the Miller COP office, where complaint forms will be filled out and tracked. If you need immediate police response, call 911; but if you have long-term problems like abandoned vehicles, derelict homes, suspicious neighbors, call the COP office at 938-0281 and the COP officers will follow up. There is also a need for COP Office volunteers, to spend a couple hours a week taking calls and maintaining a presence at the COP office. To sign up, visit the office at 601 S. Lake Street and fill out an application.

## **Seeking relaxation at the beach**

The MCC Lakeshore Committee continues its efforts to make an afternoon at the beach pleasant and **safe**. In a season punctuated by drownings and disruptions, the MCC has worked to bring together residents, the Gary Park Department, a variety of police departments and the owners of the Wells Street concession to resolve issues which range from collecting refuse to avoiding fights.

Unruly conduct on the beach is thought to be closely related to alcohol consumption, especially by underage drinkers. Efforts to reduce drinking include changes in police patrolling patterns, as well as signs to remind people that alcohol is not permitted on the beach. As a result of the committee's activities, everyone associated with the beach was geared up for the Labor Day weekend, but bad weather kept all the beachgoers away. The committee plans to work with the incoming city administration to assure that all parties are ready for next year's beach season.
