## **Report from the August 2012 meeting of the MCC board**

### **EDUCATION AFFAIRS.**

Dr. Adrian Richie, the new principal of the Wirt-Emerson High School, appeared at the invitation of First District School Board Member Barbara Leek, to introduce himself to the MCC Education Committee and the MCC board members. Dr. Richie grew up in Gary, but he began his career as an educator about 30 years ago in Houston, TX. Most recently, he has been a school administrator in Lowell, IN. **He noted that the student body at Wirt-Emerson will include grades five through twelve, and will be divided between an arts group and a high ability group. The school year will be divided into three trimesters of 12 weeks each, and class periods will be 70 minutes in length.**

The MCC Education Committee has complained that members tried to volunteer their services in the Gary schools, but the previous principal at Wirt-Emerson had not forwarded a single volunteer application to the central office. Dr. Richie, in contrast, was receptive to the idea of having volunteers help out in the school, and he can be expected to approve such applications in the coming year. He believes volunteers would be helpful in the classrooms to facilitate his “discovery approach” to learning, and in the halls to provide increased security.

School Board member Barbara Leek appeared, to correct misconceptions concerning the Gary schools’ policy on courses for dual high school and college credit. She noted that the school city does have arrangements for such classes in collaboration with Purdue North Central, and has talks under way with Indiana University Northwest (in Gary). However, the Gary schools do not have joint credit classes with Purdue Northwest because the Hammond campus chooses to work exclusively with the Crown Point schools.

### **MARQUETTE PARK RENOVATION**

The promise is that the work on the Pavilion will REALLY be completed in September and everything else will be done before winter. Seeing the roads paved is an encouraging sign of progress. However, on controversial issues where the MCC representatives expressed an opinion, we have never gotten to first base.

From the start, the MCC (and the Regional Development Authority, which is funding the project) insisted that the city agree to a park management plan which included a “park conservancy” with shared responsibilities between the city and the outside support group. Both Mayor Clay and Mayor Freeman-Wilson have dragged their feet on this issue, and in the end, the city has put forth a management plan which retains full control with the city. The claim is that the Marquette Park facilities will generate enough revenue to pay for park maintenance, recognizing that the city does not have money to contribute to this effort. Carol Smith, the MCC lakeshore committee chairman, is willing to give the city a chance to show that this approach will work.

When the construction schedule called for closing the Lake Street boat ramp in the middle of August, we initially got the city to agree to keep it open through Labor Day. However, they reneged on this promise and closed the ramp early, with the argument that the revenue we lose does not justify the cost we would incur if all the work is not completed before snow falls.

Many Miller residents have objected, from day one, to the plan for a single lane of automobile traffic through the

park, but the planners have not reconsidered their decision.

Very recently, observers have been dismayed by the triangular traffic island unexpectedly installed at the intersection of Oak Avenue and Montgomery Street. However, the last-minute objections of the MCC did not prevent the island from being completed.

**Local residents who have followed the design and construction process uniformly complain that the planners have held all the required public meetings, but have paid no attention to anything which members of the public have said at those meetings.**

### **OTHER ISSUE.**

The MCC board has voted to support the request for a liquor license at Angela's Pantry, our new restaurant on Miller Avenue, thereby drawing a line between **restaurants** which we promote and **strip joints** which we don't.
