

## Ed Asner to appear as FDR

The Miller Beach Arts District, in collaboration with Mark Spencer and Mass Media VII, will present television, stage and film star Ed Asner in a one-man show as President Franklin Roosevelt in **FDR**, at the Marquette Park Pavilion on Tuesday, March 12 at 7:00 pm. From Broadway in New York, this will be an exclusive performance in the Chicago area. Reviewer Steve Seigel calls the performance “a tour de force of the actor’s craft, as intensely physical as it is emotional.”

General admission tickets will be \$35, but the Arts District is also soliciting contributions and is offering special rewards for high-end donations at the levels of \$5,000, \$2,500 and \$1,000, payable by check to the Miller Community Fund.

The Arts District is also planning events later in the year which will feature actor John Amos and jazz pianist Ramsey Lewis.

## A shock for charter schools

Ball State University, which has been the main sponsor of Indiana charter schools, has announced that it is not renewing the charters of the Charter School of the Dunes (CSD) and the LEAD Charter School in Miller. Leaders of the CSD were especially dismayed by this news, since they have just negotiated large bank loans to finance construction of their new school buildings at the corner of Rt. 20 and Old Hobart Road. All the bank deals were closed with support from Ball State, with no hint that the school’s charter might be withdrawn. The CSOD has about 400 students from kindergarten into high school and would be offering a K through 12 education in their new facility. Charter School board president Danielle Sleight reports that the school is appealing the decision by Ball State, with a hearing to be held in the next several months. They are also exploring the possibility of obtaining sponsorship from some other 4-year college. Meanwhile, construction of the new school facility is continuing.

The CSD is encouraging supporters to **call the office of Ball State’s President, Dr. Gora, at 765-285-5555 to request that the charter be renewed.** They could make a plea for the LEAD school as well. **MARQUETTE TRASH STATION STILL AN ISSUE.** Many Miller residents have been offended by the placement of the trash collection station at the east end of Marquette Park, where it is the first thing **all** visitors to the park see when they pass the intersection of Oak Avenue and Montgomery St., which is the only way into the park. Mayor Freeman-Wilson has been presented with several options for dealing with this eyesore, all of which seem unreasonably expensive, but she has made no decision on what to do. Meanwhile, George **Rogge has solicited independent bids for simply removing the offending structure. He has obtained an offer from a registered Gary contractor to dismantle the trash collection station for \$2,500 and he has located private funding to pay the bill.** The Aquatorium Society has

also offered to let the operators of the sandwich stand dump their rubbish in the Aquatorium dumpster. These offers have been conveyed to the Mayor through City planning director Dwayne Williams, but there has so far been no response.

## **Tax issues are forever**

Last summer, workers prowled the neighborhood, measuring and photographing properties as part of the mandated general reassessment, to assure that records accurately reflected the size, composition and other features of each property. Meanwhile, the MCC Tax Committee was working behind the scenes to assure that the land values assigned to properties were consistent and

reasonable. In the previous several years, there were significant problems with land values in the area of Miller north of Oak Avenue but south of the lakefront.; Many of these properties were assessed with beachfront rates which greatly exaggerated their value.

Last fall, a group of Miller residents, led by George Rogge, met several times with county assessor Hank Adams, to assure that these anomalies would not be included in the new reassessment. They ended up with an agreement that all residential properties involved would be assigned to the same neighborhood code – 2500 – with a value of \$900 per front foot. However, when the assessment notices came out, the assigned value was \$1,500 per front foot—an unpleasant surprise for the property owners. Going back to the county assessor’s office, Rogge determined that the State Log of Tables did assign a value of \$900 per foot to Code 2500, and this information had been transmitted to the Township Assessor in time to have it reflected in the Form 11 documents which were recently sent out. We are now pressing Jackie Collins to correct the assessment records, so they agree with the state-authorized values, before the tax bills are sent out.

**Apart from this particular problem area, it appears that assessments rose slightly compared with last year. If this results in a valuation which the property owner feels is out of line, his only recourse is to submit an appeal, which he must do within 45 days of receiving his Form 11 notice of assessment. Hopefully, there will be fewer appeals than in the past several years, and appeals will be heard on a more timely basis.**

## **Education committee influences Gary Career Center expansion**

The MCC Education Committee, represented by Jason Arndt, has been urging the Gary Community Schools to make classes at the Gary Area Career Center available to a larger number of students. The Career Center focuses on vocational education in a variety of crafts, but only high school juniors and seniors with a grade-point average above 2.5 have been allowed to attend. Our committee members felt that younger students would also benefit from this curriculum, and the opportunity for vocational training might keep in school many of the students who currently drop out.

Arndt has recently heard from Dr. Pruitt, the School Superintendent, that the schools’ policy has changed and freshmen and sophomores are now being admitted to the Career Center. Pruitt is also working to expand the course offerings at the Career Center.
